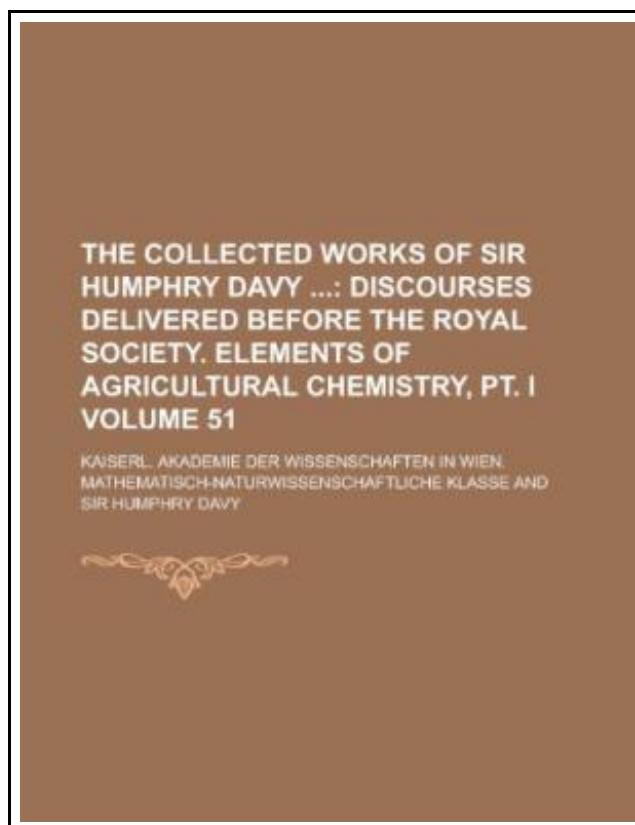

Excerpt: . . . 11 On June 1, 2009, pursuant to the Omnibus Appropriations Act of 2009 ( as clarified by the Credit CARD Act of 2009 ) the Commission commenced rulemaking 31 proceedings on unfair or deceptive mortgage-related practices: This week, the Commission issued a notice of proposed rulemaking, seeking public comment on a proposed rule covering loan modification, foreclosure res-cue, and other mortgage assistance relief services. The rule would ban pro-viders from collecting fees prior to delivering the promised results, prohibit misrepresentations in the marketing of these services, and require certain af-firmative disclosures about the nature and terms of the service. The Commission anticipates publishing a second notice of proposed rule-making in the near future addressing mortgage advertising practices, followed by a third proposed rulemaking addressing mortgage servicing. On August 19, 2009, the Commission published in the Federal Register proposed 32 amendments to the Telemarketing Sales Rule ( TSR ) designed to curb decep-33 tion and abuse by providers of for-profit debt relief services. The amended rule proposed by the Commission would, among other things, prohibit debt relief service providers from charging consumers a fee until they have delivered the promised results. The Commission staff is considering the public comments the agency received in response to the proposed rule and has begun drafting a final rule. The Commission, in conjunction with the Federal bank agencies, also has pro-mulgated rules to protect the privacy of consumers sensitive information, in-cluding financial and credit report information, under the GLB Act and the 34 FACT...
